



Required information


Filed within the time limit

Accuracy for before filing electronically

Operative reports, progress notes and lab results

Rejected Claim

Incorrect information on the claim and requires further investigation

Electronic claims 16 – 31 days

Sort follow-up by financial payors

Research denials within in 15 days of receipt





Enacted March 2, 1863

Safe and healthful working conditions for working men and women

Created under the Nixon administration

Federal Anti-Kickback Law

Penalties for individuals or entities that knowingly and willfully offer, pay or solicit and receive remuneration to induce or reward the referral of business under any federal healthcare program

Privacy Act of 1974

Provides safeguards against an invasion of privacy through the misuse of records by federal agencies.
