

ONLINE COURSE INFORMATION

Thank you for booking your online training with Fakealicious Training Academy. Please ignore the document 'important information about your course' this is for 'in salon training'. You do not need to attend the academy or be available for the time/date you have booked. Online training can be done within your own time schedule within a 6 month period.

All your theory work, test & video is available here.

You will need to read through your training manual & watch the video to help you. For all courses you will need to send in case studies of either videos or pictures (details below) on some cases this can be used as your final work, in others it may be marked as 'practice'. Details of what you need to provide for individual courses is below:

Beauty courses

Brow Lamination, defined henna brows, spray tanning, lash lift

You will need to send 1 before & after picture & a short video of each part, this can be a time lapse video.

Waxing

You will need to send over a video of your technique (applying the wax & removing the strip) for at least 1 area, ie 1 leg or 1 arm (these are usually easier to start with). Once I'm happy with your method you can then do your case study sending a 5 minute video as well as before and after pictures of all areas.

Lash (classics & volumes)

You will need to send over a video of your technique (isolating the lash and lash application), you will also need to send a before & after picture, you should first work on a dummy head, once I am happy with this you can progress onto a client & you will need to send before & after pictures.

Makeup

There is no video as yet for makeup, you will need to read through the training material and explore YouTube and decide which look you would like to go for & send before & after pictures.

Skin Tag removal

This treatments will require you to send videos of practice work as well as your case study. You will need to do at least 3 skin tags &1 flat sunspot or freckle.

Nails Nail extensions

You will need to practice on either a mannequin hand, yourself or another person. You will need to do practice work before & send 1 before & after picture, Please take pictures of the process 1. Before 2. tips applied 3. Blended 4. Acrylic/gel application 5. Finish, you may also need to send videos of forming your 'acrylic beads'. Once this is passed you can send over your case study with the same picture processes as above – this can be on a mannequin hand or ideally another person.

Gel Nail Overlay, Gel polish & SNS

You will need to practice on either a mannequin hand, yourself or another person. You will need to do practice work before & send 1 before & after picture, Once this is passed you can send over your case study with a before & after picture this can be on a mannequin hand or ideally another person.

Manicure & Pedicure

You will need to practice on another person. You will need to send before & after pictures & a video of your massage technique. Once practice is passed you can then send your case study with a before & after picture (at least 1 case study must have nail polish)

Skincare

Facials, chemical peels, Dermaplaning, Microcurrent, Microdermabrasion, High Frequency, Galvanic, Vacuum Suction, Microneedling/Dermaroller, B.B Glow & Electrical Body

These treatments will require you to send videos of practice work as well as your case study. To practice just using instruments you can do this on yourself to ensure you are using the correct pressure & method. Once I am happy with your practice you then will need to video the treatment for case study, you do not need to video the whole treatment, for instance for facials you will need to record the massage, Dermaplaning

just record using the Dermaplaning pen & so on, or you can video the whole treatment using time lapse. For electrical body you will just need to record 1 minute of using each devise. For all treatments you will also need to send before & after pictures.

To send pictures & vids it will be easier to WhatsApp me on 07943095210, I'm here for any questions, feedback on practice etc.

COVID-19 – due to social distancing, Tiers & Lockdowns continually changing if you do not have anybody in your household to work on & you are not allowed to work on the public you can improvise on dummy heads, mannequin hands or yourself.
