

Finding lost animals using animal communication

Why lost animal cases are difficult

You might be wondering why lost animal cases are so difficult in comparison to regular communication cases. Many variables need to be taken into account if you are going to work with lost animals. Unlike a normal communication, lost animal cases are ongoing, extremely emotional and time consuming. Some cases can go on for months or even years so you need to be able to commit when you agree to take on a lost animal case. An animal who is missing can be constantly on the move, if the animal is scared or injured, they may find it hard to communicate with you. The animal does not always show you where they are but where they have been. After a few days of being lost, an animal can revert to their natural instinct to survive and may act almost feral. This is especially true for cats or animals of a shy or nervous disposition and they may not come straight away when you call out and might avoid approaching anyone trying to help them. These are just some of the things that make working with lost animals hard and are things you should be aware of, another is that getting a lost animal home is not always just about finding them, but about learning from them why they went missing in the first place. Be prepared that some animals might tell you they left deliberately and whatever reason they had for leaving, you would need to talk with both the animal and the animal's person to resolve some issues before the animal is happy to return.

Above all, one of the hardest moments that a communicator will have to face on a lost animal case is when the guardian wants to know if their animal is alive or deceased. Some people can be incredibly insistent about getting an answer to this question for obvious reasons. The "problem" with answering the question of if the animal has died is that the soul never dies and in some cases, if an animal has died suddenly they are not immediately aware that they have passed and their spirit can continue to move around the earth as if it was still in its body. So, when a communicator checks in with an animal that is lost the animal may well convey to them that they are still moving and continue to describe what they see around them. This is especially common in animals that have been killed on roads or by wild animals and is similar to being in a state of shock. This can happen because they are alone and there is no interaction from outside forces such as other people or animals to draw their attention to the fact that they have passed suddenly. This is not a long-term state and usually the animal realises she has passed once she finds a moment to relax and focus herself. It can for obvious reasons be very upsetting for an animal's guardian to be receiving information from a communicator that their animal has experienced this and seen that only to discover that the animal actually passed away days before. You should know that it isn't any fault of the communicator, it is as I have stated because even in spirit the animal is still alive and sees herself as such in many ways.

Rather than trying to discover if an animal is alive or dead, try to get reassurance that the animal is alive. You can try to do this by asking the animal questions about her physical condition. An animal that is lost but still alive will be able to tell you how her body feels; many will describe being in pain or being tired or hungry. An animal that has passed will not share information about her physical state because she no longer has one. Now, an animal in spirit will happily tell you that they are no longer in physical pain and many will describe how they "look" in spirit but this is done for the benefit of the animal's person, as they have no actual physical body to speak of.

Another important point to note is that animals are born aware of the afterlife; it is one of the reasons that they view death differently to us. The reason this becomes important in lost animals cases is that sometimes an animal will refer to having passed over as having gone "home". So when asking if the animal is going to return home it helps to be more specific and include something like, "home to your house with your family".

In times of extreme distress it is possible for an animal's soul to temporarily leave the body, if a communicator were to check at this moment if the animal is "in her physical body" and receive a no, the communicator might wrongly tell the animal's person that their animal has left her body. She has left her body yes, but she will return, and what if her person is now no longer looking for her because they believe her to have passed away. Maybe the animal is in extreme pain and so temporarily left her body but is still very much alive, how horrible to think of no one coming to find her.

Following on from this, a common mistake that some students of animal communication make is to assume that if they connect with the animal and receive nothing it is because the animal has passed away. This is not the case and telling the animal's guardian this can lead to a lot of unnecessary hurt and distress for the person and the animal. What many people aren't aware of is that sometimes when an animal is missing, she will leave her body temporarily via astral projection in an attempt to search for the best route home. Astral projection is when the animal's soul makes a conscious decision to temporarily leave the body. During this time that the animal's soul is travelling, she might not respond to telepathic messages and if the communicator attempts to feel if the animal is in her body, they will obviously feel that she isn't and then might wrongly assume it's because she is now in spirit.

A less commonly known reason for why a communicator might wrongly believe that an animal has died is that when an animal fears for her life she will sometimes share with a communicator what she fears might happen to her. She might show with detail her being attacked by another animal or being hit by a car. This doesn't mean it has actually happened or will happen; she might just be looking for reassurance from the communicator. Sadly though some communicators take this to mean the animal has indeed suffered that fate and they tell it to the guardian without actually knowing or checking why the animal showed them that.

The concept of being alive or in spirit is far too subjective in my opinion to be able to give an animal's person a definitive answer when an animal's life could be at stake. I still shudder when I read or hear of some communicators telling an animal's guardian that their animal has passed away while missing. Unless you have physically seen the animal's body yourself I think there is never any excuse for telling someone that you believe their animal has passed. Just the other week I read a post from a devastated man because a communicator had told him very clearly that his dog had died after being hit by a car while lost. This man had even gone as far as telling his friends and family that the dog had passed and holding a funeral for his dog with his children. A week later, the dog was found and returned to him. Which is obviously wonderful news, but firstly, this poor man and his children spent a week absolutely believing that their dog was dead and secondly, what if the dog hadn't been found? This man wasn't going to continue searching for a dog he had been told was now passed. Just don't do it. No matter how much you might want to give someone closure or how strongly you believe it to be true it is not worth the risk you put on an animal's life if god forbid you turn out to be wrong.

I feel it is necessary to say that if you want to work on lost animal cases you really are going to need to have a lot of patience and above all compassion. When you work with someone, who has an animal missing you are likely going to be experiencing him or her at their very worst. They will be feeling guilt, sadness, grief, frustration and despair on a daily basis. For some of them they will have been living this way for weeks, months or sadly even years as they search in desperation for an animal who may be their whole world.

You should know that if you work on these cases you would likely come across people who are rude, impatient and maybe even ungrateful. It helps to know though that they might have been made that way through disappointment after disappointment. I don't ever think there is justification for people to be mean to someone else just because they are suffering, but it does help to know that in most cases, it isn't personal and they are just someone lashing out because they are frantic to find their beloved animal.

Obviously if someone continues to disrespect you in any way I would always advise that, you wish them well and walk away. Just make sure you have given them the benefit of the doubt first and taken into account that having an animal missing is a daily torture for many people and that might make them behave in ways that they normally never would. Likewise, if you are the guardian of a lost animal try not to overwhelm the communicator you are working with. Having an animal missing causes a huge amount of anxiety and worry, but please avoid contacting a communicator at every hour of the day and night for updates about your case. Or to insist that they give you certain information or expect them to perform miracles. If someone is working on your case it is likely because they really want to help you, please don't make that difficult for them by being rude or pushy.

I had a very difficult case with a lost dog, the dog had already been missing quite some time by the time I was contacted, and the dog's person had already spoken to dozens of different mediums and psychics all of whom had been unsuccessful. By the time this man spoke with me it was almost impossible to get him to follow any of the instructions I gave him and it soon became clear that he expected the dog to literally fall into his lap. The information I received from the dog lead us to believe that she wasn't missing anymore and had been taken in by someone else, which matched with what the guardian himself believed to have happened, as there had been no sightings of her for some time.

I spent days connecting with the dog until I was finally able to track her down to an actual street and one house in particular. I will not go into any more detail than that but sadly to say the guardian had his own reasons for not wanting to check the house and that was when I decided to withdraw from the case. I check from time to time and I see that the dog is still missing; it has been 5 years now and I so hope that this poor man gets closure one day.
