FOR STRIKING

- Doctors like all members of society have the right to freedom of speech. They should not be exempt from this solely due to their profession
- Example: In 2017, doctors striked as they believed patient safety was compromised they are therefore not abandoning their duty of care
- If strike action isn't carried out, doctors will lose morale and working conditions may be harmed therefore indirectly affecting patient safety
- The NHS is the main healthcare provider by over 95% hard for doctors to transfer to another employer if they are unhappy therefore should be allowed to have a say

AGAINST STRIKING

- Doctors must follow the GMC Code of Conduct which states that they must be professional at all times and be responsible for patient safety this could be compromised by striking as well as the ethical principles of non-maleficence and beneficience
