

Summary of Substantive Corrections and Changes Made to the 2023 Rulebook since Aug. 1, 2022, Posting

Dec. 1, 2022

- **Page 39, Rule GR 1.08**
 - Added new rule GR 1.08 as approved by the U.S. Figure Skating Board of Directors on Aug. 8, 2022. Per Article XVII, Section 4, this action is not subject to alteration or cancellation by the Governing Council, as such action would contradict applicable law, rule, regulation or policy of a regulatory body or organization with jurisdiction over U.S. Figure Skating. This language is required through the USOPC NGB Certification program, in accordance with Section 22024(a)(10) of the Ted Stevens Olympic and Amateur Sports Act, as amended.

- **Page 135, Rule 2721**
 - Corrected references to rules 2501, 2502 and 2503 as it relates to the draw groups for the initial starting orders at the U.S. Figure Skating Championships.

- **Rules 2423, 6420, 6430, 6440, 6450, 6460, 6470, 6480, 7420, 7430, 7440, 7450, 8420, 8430, 8440, 8450 and 8460.**
 - To update the applicable rules for the Dec. 1 implementation of Item 113 from the 2021-22 Combined Report of Action, which removes restrictions capping the highest singles, pairs and ice dance tests competitors may have passed to compete in a corresponding level and add a notation that athletes are not permitted to move backwards to a lower level once they have competed in a qualifying competition (i.e. “decoupling of tests”).

- **Pages 189-208 and 221-228, Rules 6411-6561 and 7411-7451, Singles and Pairs Elements**
 - Updated the step sequence information to make sure the language is consistent and added information to the remarks.

- **Pages 284-287, Rules 8521, 8525, 8531, 8535, 8560, 8570, 8580, 8590**
 - Made some formatting changes to the test qualifications for consistency and ease of reading.

Sept. 19, 2022

- **Pages 170, 182 and 183**
 - No changes were made to any text, but page 182 was missing from the previous version, and pages 170 and 183 were each appearing twice.

Sept. 1, 2022

- **Page 41, Rule MR 1.02**
 - Corrected the accidental omission of the word “annually” in the first sentence.

- **Page 165, Moves in the Field and Free Skate Test Codes**
- **Page 167, Pattern Dance Test Codes**
- **Page 170, Rule 5013**
- **Page 183, Rule 6213**
 - Corrected references to Skate United pre-preliminary tests. Because pre-preliminary tests are not marked with a numerical score, all tracks start with the same standard test.

 - Corrected the “Candidate” column for the adult pre-bronze moves in the field test.
