AUSTRALIAN TAXATION OFFICE (INC.)

1. **What is - AUSTRALIAN TAXATION OFFICE (INC.)** THE FIRST ATO MEETING discusses the actual story of this foreign corporation.

1. A Background.

- EFP has been fighting in the courts since 2017, supporting our community in the Bank-Court-System.
- The material & information has been used in court-houses, for Banking, Council & Police Court cases.
- EFP has been trusted by The Elders of the UNITED TRIBES, to take their documents, & File these important documents into all of our court cases.
- Today, we have the ATO Certified Affidavit which has been submitted back to the Commissioner & the Deputy Commissioner – with NO RESPONSE!

2. The Reason for our arguments – We are NOT advocating NON-PAYMENT?

- There are many newly formed online groups, seeking memberships & trying to ‘SELL THEIR CD’s & BOOKS’. Many sell – ‘DO NOT CONTRACT – IGNORE THEM!!!’
- After our experience in the courts, we take the approach of challenging the Authority & Jurisdiction of a NON-GOVERNMENT AGENCY, to ASK YOU FOR YOUR MONEY???
- We have made the case & we DO NOT ADVOCATE NON-PAYMENT! We are making our case that THE ATO (or other corporation) MUST PROVE IF THEY ARE LEGAL & LAWFUL with a required – COMMERCIAL CONTRACT, in order to ‘ASK YOU TO PAY THEM, WITHOUT CONTRACT!’
- We state in our affidavit that we - MUST BE PROVIDED ‘PROOF OF THE OWNERSHIP of THE ATO’, & ‘WHEN WAS THE CERTIFICATE OF LICENCE PAID TO THE ELDERS???’

3. The EFP Certified Affidavit – An explanation.

- Tonight, you will see, the EFP CERTIFIED AFFIDAVIT, with the argument that we can support, with the Facts, that the AUSTRALIAN TAXATION OFFICE (INC.) is a CORPORATION.
- We have the public document (since removed) that the AUSTRALIAN BUSINESS REGISTER SERVICE (ABRS) & THE AUSTRALIAN SECURITIES & INVESTMENTS COMMISSION (ASIC) have confirmed & published that –
- COMMONWEALTH BANK LTD., & BLACKROCK INVESTMENTS (AUST.) are two of a list of Shareholders of The ATO (INC.), &
- The MAIN PROBLEM is the CERTIFICATE OF LICENCE, from The ELDERS, of THE UNITED TRIBES, noted on the GRANDMOTHER LORE NOTICE.
- This Certified Affidavit has been submitted, by EXPRESS POST (AUSPOST) & received & accepted by the POST OFFICE, as DELIVERED!
- We will preview this Affidavit after this presentation.

4. The GRANDMOTHER LORE NOTICE & UNITED TRIBES COPYRIGHT TRADEMARKS

- We have been trusted by – THE ELDERS of this Land, to use the ‘UNITED TRIBES COPYRIGHT TRADEMARK’ document, for all of our court cases.
- The Original document, the ‘UNITED TRIBES COPYRIGHT TRADEMARK’ document, was widely shared & used.
- This was expanded, & the document developed into the current – ‘GRANDMOTHER LORE NOTICE’ which includes the Fact that –
- The Secretary of The GOVERNOR-GENERAL is an INCORPORATED OFFICE!
- This document is recognised Internationally.

5. The International Law – The Law is on our side!

- EFP relies on Fact. Not AUSTRALIAN LAWS, which are defective & disabled, but ‘The INTERNATIONAL LAW’, being –
- THE HAGUE CONVENTIONS ON INTERNATIONAL LAW, TREATIES & INTERNATIONAL COPYRIGHT’, ratified by the AUSTRALIAN GOVERNMENT.
- Next, we have a proven pathway, to Filing our documents to –
- THE INTERNATIONAL POLICE (INTERPOL), at SINGAPORE, &
- THE JUDGE-ADVOCATE-GENERAL’s OFFICE (JAG), at WASHINGTON D.C., &
- THE WORLD INTELLECTUAL PROPERTY ORGANISATION (WIPO), at GENEVA, SWITZERLAND,
- Our documents have been accepted by the Office of PRIME MINISTER, THE OFFICE of FOREIGN AFFAIRS, THE FEDERAL ATTORNEY-GENERAL’s OFFICE, & THE OFFICE OF THE SPECIAL MINISTER OF STATE.
- EFP has also Filed our documents into The PARLIAMENTARY ASSEMBLY for the COUNCIL OF EUROPE (PACE).

5A. The INTERNATIONAL LAW – The Law is on our side!

- The HAGUE CONVENTIONS of 1899 and 1907
- What were The Hague conventions of 1907?
- i) The 1907 Convention consists of thirteen treaties—of which twelve were ratified and entered into force—and one declaration: (I): Convention for the Pacific Settlement of International Disputes. This convention confirms and expands on Convention (I) of 1899.
- ii) The Hague Convention was concluded on 25 October 1907, and entered into force generally on 1 December 1908. Australia ratified the Convention on 29 October 1986, and the Convention entered into force for Australia on 1 January 1987. To date, 86 countries are contracting states to the Convention.

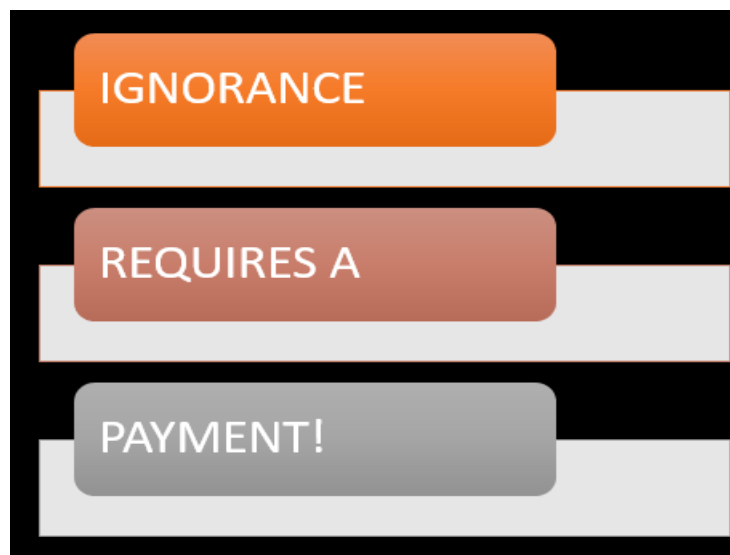
6. The UNITED ACTION – ‘United We Stand, Divided We Fall!’
