# SAVANNA3D USER LICENSE AGREEMENT

**IMPORTANT - PLEASE READ CAREFULLY:** 

This END USER LICENSE AGREEMENT ("AGREEMENT") is a legal AGREEMENT between BITS 3D Corp., 1538 NW 89<sup>th</sup> Court, Doral, FL 33178, acting on its behalf, and You (either as an individual or the legal entity for which You represent and warrant that You have the right, power, and authority to act on behalf of and bind to this AGREEMENT) ("You" or "Licensee"). **This is a license AGREEMENT and not an AGREEMENT for sale; the Models are licensed and not sold.** 

**THE MODELS are licensed to LICENSEE only upon condition that LICENSEE accepts all of the terms and conditions contained herein.** By installing, accessing, or otherwise copying or using all or any portion of THE MODELS. You agree to be legally bound by THE AGREEMENT. If LICENSEE does not agree to any or all of the terms in THE AGREEMENT, LICENSEE must not install, access, or otherwise copy or use THE MODELS and may, within thirty (30) days from the date of acquisition, return THE PRODUCT for a refund to BITS 3D Corp. or the authorized reseller of the product.

## LICENSE

## Limited License to 3D Models:

Subject to the provisions of this License Agreement (including, but not limited to, the license restrictions set forth below) and the payment of the fees, BITS 3D Corp. grants you a personal, worldwide, royalty-free, non-transferable, non-sublicense, non-exclusive, limited license to use the 3D Models and Parametric Models, for the internal business purposes described in Section **Authorized Uses** below. No other uses are granted.

According to the Agreement in relations between the Licensee and BITS 3D Corp., all the rights to the SAVANNA3D Models are and shall remain the property of BITS 3D Corp. The Models are licensed, not sold. If you desire to use the Models in a manner not expressly authorized in this License Agreement, you must submit a request to BITS 3D Corp. at https://mcneelmiami.com/contact, and receive BITS 3D Corp prior written consent before doing so. For this Agreement, Parametric Models mean Procedural Model files, meshes, surfaces, and textures, which you have specifically licensed under this Agreement for use with Rhinoceros® software.

The subject of this Agreement does not cover the so-called free samples Models available from the McNeel Miami website.

The rights under this License are vested exclusively to the Licensee.

The License is granted for an indefinite period, but you may terminate this License Agreement at any time by manually deleting the Model from your computer. If you violate this License Agreement, your authorization and License to use the Model shall automatically terminate, and you must immediately discontinue use of and destroy any downloaded Model.

The Licensee shall not sublease or transfer the rights under this License to any other entity, whether for remuneration or not.

Under the Agreement, the Licensee does not acquire any intellectual property rights or other property rights, including patents, designs, trademarks, copyrights, rights to the databases, or rights to any confidential information or trade secrets.

The Agreement is concluded by an order made directly or through one of our resellers and getting access to Savanna3D on the Rhino3D.Education portal. The conclusion of the Agreement and its provisions are confirmed by the Licensee immediately.

## Authorized Uses

By accepting this Agreement, BITS 3D Corp. grants the Licensee the following rights:

- Enter data into the computer and reproduce the Savanna3D Models.
- Process, edit and use the Savanna3D Models in their studies and works, in particular: Rendering still images and animations for commercial and non-commercial purposes (e.g., for architectural plans, interior design representations, video production, broadcasting, print, movies, advertising, game intros, illustrations, and presentations). This use does not expressly include the right to use the Models or any portion thereof as derivative products.

#### **License Restrictions**

You may not, and you may not permit anyone else to:

- copy, transfer, loan, assign, rent, resell, offer to sell, distribute or use any Model either on a standalone basis or as a part of a model library, other than expressly authorized in this Agreement.
- copy, transfer, loan, assign, rent, resell, offer to sell, distribute or use any portion of the Models either on a standalone basis or as a part of a model library, other than expressly authorized in this Agreement.
- obscure, remove or alter any product identification, proprietary, copyright, trademark or other notices contained in the Model or accessed in conjunction with or through the Models.
- claim or misrepresent ownership of any Model which you did not create or develop.
- use the Model in violation of any applicable laws or regulations or for any unlawful purpose.
- not embed or incorporate any portion of the Models into any licensed commercial productions or any other production, product or software.
- use any Models, Creations or Combined Works in a manner that competes with Savanna3D.

Except as otherwise expressly provided herein, nothing in this Agreement intends to transfer any rights to you or vest any such rights. You are only entitled to the limited use of the Models granted to you herein. You agree to prevent any unauthorized copying or use of the Models. You agree to adhere to any posted instructions, directions, or limitations on usage and reproduction of Models.
