Training context

This is a training course on the use of ISO/IEC 17020:2012, Conformity assessment — Requirements for the operation of various types of bodies performing inspection to accredit inspection bodies. The course will also cover relevant ILAC requirements, including ILAC P8:03/2019 and ILAC P15:05/2020.

The facilitators/trainers will provide insights on how this type of accreditation is conducted and participants will be encouraged to share their experiences and ask questions. Attendees are expected to be APAC Member personnel (assessors, managers, accreditation scheme developers) that are either undertaking accreditation of inspection bodies or are considering developing this type of accreditation scheme.
