Tutorial Summary

Music is a flexible medium and music therapy methods can be adapted to meet the diverse and complex needs of clients in eating disorder treatment. As music therapists, we are tasked with understanding the needs of our clients and creatively implementing music experiences to effectively and safely meet their needs. While receptive, re-creative, composition, and improvisation methods can all be effective with clients in eating disorder treatment, it is important to understand the client's primary needs at the varying levels of treatment, when a method or type of music experience may be contraindicated due to the client's physical or/and emotional health status. The music therapy methods are not determined by a specific client population, but based on it can address a client's needs and determine if there are any safety issues or contraindications that may warrant using different methods at the present level of care. This does not mean the method can never be

used with the client, that should be determined based on the client's needs at any given time in their treatment process. As music therapists it's important that we delve deeply into understanding our clients needs so that we choose the best treatment methods and evaluations. In this tutorial Dr Annie Heiderscheit covers the causes, prevalence, physical effects and behavioural symptoms of eating disorders. She discusses how music therapy can address the complex needs of clients living with an eating disorder and highlights this through case studies and descriptions of relevant methods. The tutorial concludes with the opportunity to deepen your knowledge with further reading of a recommended book chapter, completing a reflection workbook and the option to engage in deeper exploration of this topic with Dr Heiderscheit herself.
