9-1-1 SCRIPTS

WHY USE SCRIPTS?

Scripts are a very entry-level learning tool — a part of MODELING, which is a very important method of training. Modeling with scripts may seem very simplistic, it is — it is meant to be. Using scripts allows the beginning learner to get the feel and rhythm of a call they may be receiving. Scripting shows the trainee they can handle a call — once they become familiar with the types of questions that must be asked. Repeating the sequence of the questions as they should be asked solidifies the concept.

Scripting allows the trainee to enter calls into CAD, cards or your 911 simulator. The entry-level learning is designed to build confidence and skill with taking an ‘easy’ call and entering the information. We keep the call simple. Learning must begin with simple and progress always.

WHEN TO USE SCRIPTS

This is the very first step in learning — an introduction to taking a call. Use scripts when a trainee is struggling with a comfort level with call taking. You can also use scripts to train responders.

HOW TO USE SCRIPTS

The scripts are given to you in pdf Adobe XI Pro or printing can be used to modify them if you do not agree with the way the questions are asked and so that you can add your own addressing, phone number and area specific locations and hot spots. Note: Addresses and phone numbers are left blank so that you can use area specific information. Only first initials are added to names so that the caller can be male or female. Last names are given and should be used to keep from using Jones!

Once you have your scripts as you want them, make two copies of the script, one that is complete for the trainer or caller (actor) and one that is blacked out for the learner. The learner’s copy is blacked out so they do not know what to expect from the caller. Students are asked to follow the script exactly and not to deviate in any way. After repeating the scripts enough times, a habit will form.

Debriefing the script is very important. After the call the trainer and the trainee should discuss how the call went. Do you think you got all the information you needed? What else should/could you have asked? Is this the way it should be done? Does the student have any questions regarding what was asked or said. Remember this is entry level one basic learning. It’s very brief and very basic as you can see but very NECESSARY. You can design your own scripts once you see how this is done.

Entering the information is the next step. First the trainee just reads the script. Next the trainee reads and enters the script into CAD or other card or simulator. The learning here is to talk and type and create a very simple call to review.

Dispatching the call is the final step. You may not be training the call takers to dispatch but have them put the call out anyway in the most simple format. This will help the call taker learn why it is important to get certain types of information for the dispatch portion of the call.

Tip: Another fun learning technique is to let the TRAINEE design some scripts. You will be surprised how much learning is going on with this simple exercise.

CALLER SCRIPTS

Sure, well, this is a good start.

ALARM

This is operator 23 at Security Alarm, we have a motion detection alarm at (give address) it went off 5 minutes ago. It covers the lower level of the home, the back sliding doors and windows.

What is your call back number?

Are you contacting the homeowner?

Yes, I called her before I called you. Her name is Janie Kemp and it will take her about 10 minutes to get to the house.

Did she say anyone should be at the house?

She said they have no animals and no one should be there, she lives alone.

What is Ms. Kemp driving?

I didn't ask her.

Are you sending someone out to the home?

No, we don't go out if the owner and the police go.

OK, I'll get an officer dispatched out there.

BOMB THREAT

I just received a bomb threat at my abortion clinic.

What is the name of the clinic and the address?

Are you calling from inside, are you in danger?
